- · The additional fields will greatly assist with member servicing and claim processing.

- $\cdot$  Column headings are mandatory and must match this document and should not be renamed.
- · Do not password protect, hide columns, freeze cells or insert spaces in blank fields
- · File type is limited to XLS and XLSX
- · Bank Branch codes although we accept all bank branch codes ideally, we would prefer to receive the universal branch code for each of the banks refer to Appendix 1 for the list of universal branch codes
- · When downloading the current payroll data from the My Corporate Services web, the system will read some columns as binary, in other words the values will reflect as a number e.g. Monthly = 12
